The meeting of the Hospital Bids and Awards Committee (HBAC-A2) held on 13 October 2022 at the Derma Conference Room, 2nd Floor, OPD Building was called to order at 2:05 pm and was presided by Dr. Emelito O. Valdez-Tan, Chairperson of HBAC-A2.

Business Matters:

1. The Chairperson introduced himself, the members of the HBAC-A2, the end-users and technical working group.

*** OXYTOCICS & TOCOLYTICS**

- ➤ Framework Agreement List for Oxytocics and Tocolytics was presented to the suppliers and Approved Budget for the contract was announced to the suppliers as ₱806,593.20 for 7 items and delivery period is within seven (7) working days after issuance of a Call-Off.
- No queries from the bidders for Oxytocics and Tocolytics.
- > Dr. Coloma asked the Chairperson with regards to the quantity indicated in the Framework Agreement if it is for one (1) year.
 - The Chairperson replied that it is for one year consumption and quantity was reduced due to budget constraint and also added that the bidders should input their price if it happens to be above ABC to be used as market research for the next bidding.

- Dr. Coloma (TWG) said that hopefully we can get high quality drugs since the
 price indicated in the list are comparable to drugs in the market of high quality
 and also stressed on how to report drugs with adverse reaction.
- Dr. Cariño (BAC Member and Chairman of Pharmacy and Therapeutics) replied
 that they established a sub-committee on adverse drug reaction and shall be
 receiving all the reports which will be forwarded to the Therapeutic
 Surveillance Committee of DOH and the Therapeutics will be the one in charge
 to remind or call the attention of the supplier of that respective drugs.
- ➤ Bid Data Sheet is presented to the suppliers and Similar contract shall refer to as "various drugs and medicines"
 - Dr. Coloma asked with regards to the requirements indicated in 21.2 which was Certificate of Good Performance and Certificate of Availability of stocks since they were informed of the unavailability of stocks from suppliers which causes for cancellation of Purchase orders/Call-off.
 - The Chairperson replied that those requirements were put in place to make sure that the suppliers have good standing with the other institutions they are delivering with (Certificate of Good Performance from Jose R. Reyes Memorial Medical Center and at least two (2) other government hospitals) and for Certificate of Availability of Stocks (Letter of Assurance as to availability of stocks and prompt delivery of goods) during contract implementation, this is to make sure that suppliers have sufficient stocks and can deliver in a timely basis and they will be liable if they cannot deliver.
 - The Chairperson also added that Certificate of Availability of Stock must be notarized so it will be more binding.

❖ OPHTHALMIC & ENT DRUGS

- Framework Agreement List for Ophthalmic & ENT Drugs was presented to the suppliers and Approved Budget for the contract was announced to the suppliers as ₱1,688,239.20 for 24 items and delivery period is within seven (7) working days after issuance of a Call-Off.

- ➤ The Chairperson announced to the bidders that Certificate of Availability of Stocks (Letter of Assurance as to availability of stocks and prompt delivery of goods) during contract implementation must be notarized.

- ➤ The Chairperson announced to the bidders that Certificate of Availability of Stocks (Letter of Assurance as to availability of stocks and prompt delivery of goods) during contract implementation must be notarized
- No queries from the bidders.

 - The Chairperson responded that it must be in the local market within the last two (2) years which was also approved by the TWG.

ANALGESIC DRUGS, ANESTHETIC DRUGS & MUSCLE RELAXANT

- Framework Agreement List for Analgesic Drugs, Anesthetic Drugs & Muscle Relaxant was presented to the suppliers and Approved Budget for the contract was announced to the suppliers as ₱11,269,842.00 for 51 items and delivery period is within seven (7) working days after issuance of a Call-Off.
- Representative from Pharma Surrey asked with regards to Certificate of at least two (2) years in the local market [Certificate of Product Registration approved by the Philippine FDA] if applies for all drugs and medicines.
 - The Chairperson replied that it is applied to all the categories which is included in the Early Procurement Activity (EPA) of Various Drugs and Medicines CY 2023.
- ➤ The TWG said that IM,IV must be added for Item no. 11 Diclofenac Inj.: 25mg/ml, 3ml
 ✓ Thus item was modified to "Diclofenac Inj.: 25mg/ml, 3ml (IM,IV)"
 - the stable of th
- Similar contract shall refer to as "various drugs and medicines"
- The Chairperson announced to the bidders that Certificate of Availability of Stocks (Letter of Assurance as to availability of stocks and prompt delivery of goods) during contract implementation must be notarized
- Representative from Pharma Surrey asked where they will request the Certificate of Good performance from JRRMMC.
 - The Chairperson replied that they should inquire to Procurement Management Department (PMD) with regards to the said document.

PULMONARY DRUGS

- ➤ Framework Agreement List for Pulmonary Drugs was presented to the suppliers and Approved Budget for the contract was announced to the suppliers as ₱2,443,078.80 for 22 items and delivery period is within seven (7) working days after issuance of a Call-Off.
- ➤ Representative from Kain's Trading clarified with regards to Certificate of Good Performance from Jose R. Reyes Memorial Medical Center and at least two (2) other government hospitals if it is "Certificate of Good Performance from Jose R. Reyes Memorial Medical Center or at least two (2) other government hospitals" because they don't have any transaction yet from Jose R. Reyes Memorial Medical Center.
 - ✓ The Chairperson replied that they can submit a certificate which was certified by their company that they don't have any transaction or contract with Jose R. Reyes Memorial Medical Center.
 - Representative from Kain's Trading asked who will be the signatories for Certificate of Good Performance which they will request from two (2) other government hospitals.
 - The Chairperson replied that it will depends on the hospital or procurement office who were their authorized signatories.
 - Representative from Oxford clarified if they can use the Certificate of Good Performance which they have requested from PMD this year or if it is specifically for a certain procurement only.
 - The Chairperson asked the representative what was indicated in their Certificate, if it was particular to a certain procurement or if there is validity in the certificate.
 - The Representative from Oxford replied that it is specific for bidding purposes.
 - The Chairperson said that if it is specific for various drugs and medicines then it is acceptable.
- > Representative from Oxford inquired with regards to On-going government and private contracts if attachment is needed.
 - The Chairperson replied that there is no need to submit the attachment for Statement of all its on-going government and private contracts within the last TWO (2) years prior to the deadline for the submission and opening of bids, including contracts awarded but not yet started and for Single Largest Completed Contract supporting documents must be attached.
- > Representative from Oxford inquired if the renewal documents is needed for the Certificate of Product Registration
 - The Chairperson said that they can submit the following documents for Certificate of at least two (2) years in the local market (Certificate of Product Registration approved by the Philippine FDA)
 - in lieu of CPR with near expiry date and expired CPR: Renewal of Registration. No application for renewal shall be accepted unless the prescribed renewal fee is paid. There shall be automatic renewal of the CPR when the following conditions are satisfied:
 - ✓ The application is filed before the expiration date of the registration;
 - ✓ The prescribed renewal fee is paid upon filing of the application; and

- ✓ A sworn statement indicating no change or variation whatsoever in the product is attached to the application.
- Representative from EC Zuric informed the BAC that they already requested a copy of Certificate of Good Performance from Jose Reyes this year and the certificate indicates that it was for medical supplies and drugs and medicines and asked if the certificate is acceptable.
 - The Chairperson said that it is acceptable since the certificate indicates that it is also for drugs and medicines.
- Similar contract shall refer to as "various drugs and medicines"
- ➤ The Chairperson announced to the bidders that Certificate of Availability of Stocks (Letter of Assurance as to availability of stocks and prompt delivery of goods) during contract implementation must be notarized

ANTIBIOTIC DRUGS

- ➤ Framework Agreement List for Antibiotic Drugs was presented to the suppliers and Approved Budget for the contract was announced to the suppliers as ₹22,817,378.40 for 73 items and delivery period is within seven (7) working days after issuance of a Call-Off.
- Representative from One Dexcel asked with regards to Certificate of Good Performance if private contracts are acceptable.
 - The Chairperson replied that the TWG preferred if it comes from the government hospitals.
 - Representative from One Dexcel asked if they will allow if it is from other government unit.
 - The Chairperson replied that *Certificate of Good performance from LGU is acceptable.*
- ➤ Representative from Philts asked with regards to Item no. 24 Cefixime Oral: 200mg (capsule) if tablet is acceptable?
 - The TWG said that in PNF, only capsule is available thus suggestion was denied.
- Similar contract shall refer to as "various drugs and medicines"
- ➤ The Chairperson announced to the bidders that Certificate of Availability of Stocks (Letter of Assurance as to availability of stocks and prompt delivery of goods) during contract implementation must be notarized

BLOOD PRODUCTS

- Framework Agreement List for Blood Products was presented to the suppliers and Approved Budget for the contract was announced to the suppliers as ₱7,742,349.60 for 13 items and delivery period is within seven (7) working days after issuance of a Call-Off.
- ➤ Representative from Unilab, Inc. asked with regards to Item no. 5 Filgrastim 300mcg/1.2ml (IV,SC) if their offer of 300mcg/1ml is acceptable.
 - The TWG said that they can put "at least" which will be 300mcg/ at least 1ml but ABC for 300mcg/1ml is ₱1,000.00/vial compared to Filgrastim 300mcg/1.2ml (IV,SC) at ₱1,590.00/vial.
 - The Chairperson asked if the other supplier can still join, if they will change the preparation for Filgrastim to Filgrastim 300mcg/ at least 1ml and its ABC will be 1,100.00.

- Representative from Metro Drug said that they only have 1.2ml and the abc is okay even if it will be change.
- Dr. Bautista approved with the modification and said that the ABC is more advantageous.
 - ✓ Thus, Item no. 5 was modified from Filgrastim 300mcg/1.2ml (IV,SC) at ₱1,590.00 to Filgrastim 300mcg/at least 1ml (IV,SC) at ₱1,100.00 /vial which were all approved by the BAC, TWG and bidders.
- ➤ Representative from Amicare asked with regards to Item no. 4 Epoetin Alfa 4000 IU/0.4 mL, (IV, SC) (Recombinant Human Erythropoietin) if their offer of 4000IU/1ml pfs is acceptable?
 - The Chairperson said that according to PNF 4000IU/1ml is in *vial form* thus their offer is not acceptable and reminded the bidders that specification/preparation must always be in accordance with PNF.
- Representative from EC Zuric asked with regards to Item no. 1 Albumin Human 20%, 50ml (IV Infusion) if vial is acceptable?
 - The TWG replied that is acceptable.
 - ✓ Item no. 1 Albumin Human 20%, 50ml (IV Infusion) in which unit of issue is bottle was modified to *Bottle/vial*.
- Similar contract shall refer to as "various drugs and medicines"
- ➤ The Chairperson announced to the bidders that Certificate of Availability of Stocks (Letter of Assurance as to availability of stocks and prompt delivery of goods) during contract implementation must be notarized

❖ ANALGESIC DRUGS, ANESTHETIC DRUGS & MUSCLE RELAXANT

- ➤ Representative from Zuellig/Pfizer asked with regards to Item no. 14 Fentanyl Inj.: 50mcg/ml, 2ml if their offer of 100ml is acceptable.
 - The TWG said that it is just equivalent, thus it is acceptable
- Representative from One Tech Pharma asked with regards to Item no. 47 Sevoflurane Inhalation: 250ml bottle that will fit the existing vaporizer, preventing spills, sterile, or Adaptor that is durable and will fit the existing vaporizer, preventing spills, sterile, requested if it is possible to transfer the adaptor to medical supplies or other procurement.
 - The Chairperson explained that it is not possible since the drugs and the adaptor
 or vaporizer must be compatible with each other. It will cause problem if it will
 be awarded to a product that is not compatible and they can just request to visit
 the Department of Anesthesia if they want to see the actual machine.
- > Similar contract shall refer to as "various drugs and medicines"
- ➤ The Chairperson announced to the bidders that Certificate of Availability of Stocks (Letter of Assurance as to availability of stocks and prompt delivery of goods) during contract implementation must be notarized

*** CARDIAC DRUGS**

Framework Agreement List for Cardiac Drugs was presented to the suppliers and Approved Budget for the contract was announced to the suppliers as ₱25,644,563.20 for 77 items and delivery period is within seven (7) working days after issuance of a Call-Off.
