INVITATION TO BID FOR *Various Printer with Server* ***ITB No. 2025-IT-106***

1. The *Jose R. Reyes Memorial Medical Center*, through the *GOP FY 2025* intends to apply the sum of *Three Million Seven Hundred Seventy Five Thousand Pesos (Php3,775,000.00)* being the ABC to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The *Jose R. Reyes Memorial Medical Center* now invites bids for the above Procurement Project. Delivery of the Goods is required by *Thirty (30) Calendar Days*. Bidders should have completed, within *Five (5) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Prospective Bidders may obtain further information from *Jose R. Reyes Memorial Medical Center* and inspect the Bidding Documents at the address given below during *Mondays-Fridays, 8:00am-5:00pm*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *07 April 2025* from the given address and website(s) below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php5,000.00)*.
6. The *Jose R. Reyes Memorial Medical Center* will hold a Pre-Bid Conference on *14 April 2025, 10:00am* at *CBB Conference Room, 2nd Floor, Central Block Building, Jose R. Reyes Memorial Medical Center* which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before *28 April 2025; 10:00am*. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.

9. Bid opening shall be on *28 April 2025; 10:00am* at the given address below Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The *Jose R. Reyes Memorial Medical Center* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
