

LABORATORY OUTSOURCING AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Outsourcing Agreement made and entered into in Manila, Philippines, this 9th day of May 2019 by and between:

JOSE R. REYES MEMORIAL MEDICAL CENTER, with office address at San Lazaro Compound, Rizal Avenue, Sta. Cruz, Manila, represented by its Medical Center Chief, **EMMANUEL F. MONTANA, JR., MD, FPCS, FACS, MHA**, hereinafter referred to as "JRRMMC"

And

BEST DIAGNOSTIC CORPORATION a corporation organized and existing under the laws of the Philippines, with principal office at #94 Masikap Extension, Diliman, Quezon City, represented herein by its **Medicine Doctor Administrator, MS. ROSEMARIE S. BALISI**, and hereinafter referred to as the "SUPPLIER."

WITNESSETH:

WHEREAS, there are Laboratory Tests and Diagnostic Procedures needed by the patients that are not available in this Medical Center;

WHEREAS, JRRMMC invited Bids for the Laboratory Tests and Diagnostic Procedures Outsourcing Project;

WHEREAS, the SUPPLIER participated in the public bidding held on 20 December 2018 and submitted the Lowest Calculated Bid;

WHEREAS, the Medical Center Chief II and concurrently the Head of the Procuring Entity approved the Bids and Awards Committee Resolution No. HBAC-A RESOLUTION NO. 0104 s. 2019 approved last 30 January 2019, awarding the Contract to the SUPPLIER which represented that it has the resources and the capability to meet the requirements as defined under this Contract and in the Official Bid Documents.

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties have agreed and stipulated as follows:

1. That the SUPPLIER shall perform its contractual obligations in accordance with the following Official Bid Documents which are made integral parts of this Contract:

 - c. Certificate of Availability of Fund (Annex 3)
 - d. Bid Bulletin (Annex 4);
 - e. Project Procurement Management Plan (PPMP) (Annex 5);
 - f. The Bid Form and the Price Schedule submitted by the Bidder (Annex 6);
 - g. The Schedule of Requirements (Annex 7);
 - h. The Technical Specifications (Annex 8);
 - i. The General Conditions of Contract (Annex 9);
 - j. The Special Conditions of Contract (Annex 10);
 - k. The Abstract of Bids (Annex 11);
 - l. The Performance Security (Annex 12);
 - m. Terms of Reference (Annex 13)
 - n. Data Sharing Agreement (Annex 14)
2. That the SUPPLIER shall provide and render its services to JRRMMC conducting the diagnostic and laboratory procedures of patients to be referred by the latter for clinical laboratory tests and diagnostic procedures as specified by JRRMMC for each referral.
3. That the SUPPLIER represents itself as a duly licensed laboratory performing clinical laboratory tests and diagnostic procedures duly accredited with the Department of Health to operate a clinical laboratory with License no. 13-0318-18-CL-2 of TERTIARY category, Institution Based. Likewise, the SUPPLIER warrants the accuracy and reliability of the results of any or all such laboratory or diagnostic procedures it will conduct and/or undertake for JRRMMC.
4. The parties agree that all specimens for clinical laboratory tests and diagnostic procedures to be conducted by the SUPPLIER shall be brought or by the representative and/ or messengers of the SUPPLIER on scheduled pick-up times agreed upon by both parties.
5. The SUPPLIER shall carry out the tests for which the request has been made in the test request.
6. The price to be charged by the SUPPLIER to JRRMMC for the clinical laboratory tests and diagnostic procedures shall be based on the Notice of Award hereto attached, to be referred to as "Annex 2" and made an integral part of this contract. The price stated thereto shall be valid for the entire duration of this contract.

7. For those laboratory tests not included in the bidded price list and tests not currently available in this medical center, such will also be referred to the SUPPLIER. The SUPPLIER shall supply an updated price list of OTHER laboratory tests they perform with corresponding charges. This price list shall be the basis of charges of corresponding laboratory tests.
8. The SUPPLIER shall bill JRRMMC on a weekly basis and JRRMMC shall pay the first party within thirty (30) days from receipt of the billing statement covering the total number of laboratory services that were done and their corresponding fees.
9. That the total approved budget for the contract in the amount of **1,112,700.00** may not be consumed entirely during the duration of the contract because the volume of the tests required are variables and the amount is based on historical data.
10. JRRMMC shall do actual extraction and preparation of send-out specimens in conformity to the written guidelines of the SUPPLIER on sample preparation and handling.
11. SUPPLIER will send results directly to the JRRMMC's laboratory. Results of STAT request will be sent by facsimile as soon as available. Original copies will be delivered to JRRMMC's laboratory the next working day or earlier except for tests that have scheduled running days. It shall be the sole responsibility of JRRMMC to transmit test results to the Attending Physicians.
12. Test results shall be released only to authorized persons.
13. The SUPPLIER retains all report related data and documentation in accordance with the laboratory's document retention.
14. That JRRMMC shall maintain confidentiality of the operating system, techniques, procedures, price schemes, records and results obtained from the SUPPLIER, such must not be divulged or released except to patients and their authorized representatives.
15. This agreement shall commence on day of the receipt of Notice to Proceed until December 31, 2019.
16. The parties shall be prohibited from pirating, enticing or offering employment to Medical Technologists presently employed by either of the parties.


17. In the event that any provisions in this Agreement is in conflict with the rule of law or is otherwise unenforceable under the laws or regulations of the Republic of the Philippines or any political subdivision thereof, such term shall be stricken from this Agreement and shall not invalidate or render unenforceable the remainder of this Agreement.
