

B. SCOPE OF WORKS AND TECHNICAL SPECIFICATIONS:

1. Supply, delivery and installation of the whole system including supports and accessories:
 - a. Exhaust unit casing must have anti-bacterial coating
 - b. Blower, 220V, 60Hz, 220 cu.m to 990 cu.m
 - c. ULPA Filter, 99.9995% on 0.1 to 0.3 um (with certificate of testing)
 - d. Pre-filter, removable
 - e. Remote Control switch, with real time pressure difference monitoring and security alarm in case pressure difference drops permanently
2. Supply and installation of ducts including all accessories.
3. Testing and commissioning.
4. Civil Works – construction of fixed ceiling and/or partition if applicable. Restoration of all affected structures.
5. Areas to be provided by JRRMMC. Turn-over of areas will be scheduled for approval first.
6. Works must be done by a company with experience in similar project.
7. At least 3 year warranty on parts and service.

Additional Scope of Works and Specifications:

1. Submission of design/plan.
2. The exhaust blower must produce at least 12 air change per hour.
3. Exhaust air should be directed away from people and air intakes.
4. Return air is not permitted.
5. Submission of calibration certificate, if applicable.
6. Tapping of power supply, in coordination with JRRMMC-EFMD.
7. Delivery days/completion is Thirty (30) days upon turnover of the area.
8. Total number of rooms – Seventeen (17) rooms.
